The ACI-CRSI Adhesive Anchor Inspector Certification program is ACI's newest certification program. **Certification is now specified as a requirement in the current version of ACI 318-11, Building Code Requirements for Structural Concrete.**

All trades installing adhesive anchors horizontally and overhead subject to sustained tension loads will need certification, and to have inspectors available.

You may be surprised at how significantly even small deviations from proper procedures can adversely impact anchor installation. Each class requires a minimum of 6, and a maximum of 10 attendees to proceed on the scheduled dates. So mention this class or the installer class to your coworkers to maintain the proper certification for this important aspect of concrete construction.



The "Inspector" Certification cost of this program is \$400 per person. Included in the price is an Adhesive Installers Workbook, Inspectors Workbook with companion DVDs and lunch. Classes start promptly at 8:00 am on the scheduled dates. Retesting for the exam costs \$300 each.
